## • **2012 Bowl of Hygeia Community Service Award**

The "Bowl of Hygeia Award for Outstanding Community Service in Pharmacy" program began in 1958 and has been presented by TPA since 1960. Sponsored by the American Pharmacists Association Foundation and the National Alliance of State Pharmacy Associations, this award has become recognized as North American Pharmacy's most prestigious state level award." The selection criteria are as follows:

1. *The recipient must be a pharmacist, licensed within the jurisdiction in which the Award is made.*
2. *The recipient must be living. Awards are not presented posthumously.*
3. *The recipient has not been a previous recipient of the Award.*
4. *The recipient is not currently serving, nor has he/she served within the immediate past two years as an officer of the Association, in other than an ex-officio capacity, or its awards committee.*
5. *The recipient has compiled an outstanding record of community service, which, apart from his/her specific identification as a pharmacist, reflects well on the profession.*

## • **2011 Pharmacist of the Year**

**SPONSORED BY THE TENNESSEE PHARMACISTS ASSOCIATION IN HONOR OF TOM C. SHARP, SR. AND JR.**

The Pharmacist of the Year Award was instituted in 1958 to provide recognition to a member of the Association who has distinguished the profession. In 1965, following the death of Tom C. Sharp, Sr., who had served as the Association's Executive Director for 30 years, the award was presented in his honor and has since borne his name. In 2001, the Award was re-named to honor the service of Tom C. Sharp, Jr., as well as that of his father.

## • **2012 Herman Lubin Sales Representative of the Year Award**

Criteria are as follows:

1. *Licensed to practice for nine (9) years or less.*
2. *Licensed to practice in the state in which selected.*
3. *Membership in the state association in the year selected.*
4. *Practice in retail, hospital, or consulting pharmacy in the year selected.*
